RESOLUTION NO

A RESOLUTION TO MOVE TO FULL IN-PERSON LEARNING MODE AS OF MARCH 15, 2021

WHEREAS, the Dublin City School District Board of Education adopted previous resolutions setting forth the considerations and processes for the District's transition among the various student learning models for the 2020-2021 school year and resolved that the Board would make all decisions regarding movement among the School Based Pathway options identified in the District's Responsible Restart Plan;

WHEREAS, the Board has continued to consider the guidance from federal, state, and local health experts as it relates to COVID-19 and the safety of students in school, including the guidance and recommendations from the Dublin City Schools' COVID-19 Committee recommendations to the Superintendent and review of local data through the District's participation in The Ohio State University COVID-19 Analytics and Targeted Surveillance (CATS) program, and the Board remains committed to providing its students with face-to-face classroom learning while maintaining student safety protocols;

WHEREAS, the ever-growing data, research, and guidance from the health experts demonstrates that students are safe in school for face-to-face learning when safety protocols are in place;

WHEREAS, the Data/Metrics Committee met on February 25, 2021 and reviewed and considered the above-referenced data, research, and guidance as well as discussion and feedback

from the many district staff participating in that meeting and gave its recommendation to the Superintendent that a move to full in-person school learning was appropriate for all students at this time;

WHEREAS, the Data/Metrics Committee cautioned that the community's commitment to maintaining safety protocols is crucial to slow the spread and to put the District in the best position to maintain a full-in learning model;

WHEREAS, the Board believes that student learning is best achieved face to face and that it can offer a safe opportunity for student learning at this time;

NOW, THEREFORE, BE IT RESOLVED that all Dublin City School District students at the Elementary, Middle, and High school levels not enrolled in the Remote Learning Academy will move to a full-in learning model as of Monday, March 15, 2021.

NOW, THEREFORE, BE IT FURTHER RESOLVED that the Superintendent may transition all or some buildings to Hybrid or Remote Learning if staffing issues arise or such a move is otherwise necessary based upon guidance from state, local, or federal health departments.
