Count One **Kidnapping, §2905.01, F1**
Defendants Mark Christopher Reynolds
Date of Offense On or about October 23, 2020

The Jurors of the Grand Jury of the State of Ohio, duly selected, impaneled, sworn and charged to inquire of crimes and offenses committed within the body of Franklin County, in the State of Ohio, upon their oath do find and present that Mark Christopher Reynolds late of said County, on or about October 23, 2020, within the County of Franklin aforesaid, in violation of section 2905.01 of the Ohio Revised Code, did, by force, threat, or deception, remove Jamall D. Shellow from the place where he was found or restrain the liberty of him for the purpose of terrorizing or inflicting serious physical harm upon Jamall D. Shellow or another and/or facilitating the commission of a felony, to wit: Aggravated Robbery or flight thereafter.

SPECIFICATION ONE TO COUNT ONE - Firearm Specification - 3 year, §2941.145(A)

The Grand Jurors further find and specify that Mark Christopher Reynolds had a firearm on or about his person or under his control while committing the offense and displayed the firearm, brandished the firearm, indicated that he possessed the firearm, or used it to facilitate the offense.

Count Two Aggravated Robbery, §2911.01, F1

The Jurors of the Grand Jury of the State of Ohio, duly selected, impaneled, sworn and charged to inquire of crimes and offenses committed within the body of Franklin County, in the State of Ohio, upon their oath do find and present that Mark Christopher Reynolds late of said County, on or about October 23, 2020, within the County of Franklin aforesaid, in violation of section 2911.01 of the Ohio Revised Code, did, in attempting or committing a theft offense, as defined in section 2913.01 of the Revised Code, or in fleeing immediately after the attempt or offense upon Jamall D. Shellow did have a deadly weapon, to wit: a firearm, on or about his person or under his control and either displayed the weapon, brandished it, indicated that he possessed it, or used it and/or inflicted, or attempted to inflict, serious physical harm on Jamall D. Shellow.

Defendants Mark Christopher Reynolds

Date of Offense On or about October 23, 2020

The Jurors of the Grand Jury of the State of Ohio, duly selected, impaneled, sworn and charged to inquire of crimes and offenses committed within the body of Franklin County, in the State of Ohio, upon their oath do find and present that Mark Christopher Reynolds late of said County, on or about October 23, 2020, within the County of Franklin aforesaid, in violation of section 2903.02 of the Ohio Revised Code, did cause the death of Amanda Rush, as a proximate result of the offender committing or attempting to commit an offense of violence that is a felony of the first or second degree, to wit: felonious assault, in violation of Section 2903.11 of the Ohio Revised Code.
