VERIFIED COMPLAINT FOR PRELIMINARY AND

PERMANENT INJUNCTIVE RELIEF

1. This complaint concerns enforcement of Ohio Revised Code (hereinafter "R.C.") Chapter 3767 et seq., Title 43 of the O.R.C., and Title 47 of the Columbus City Code ("C.C.C."), so as to be within the exclusive jurisdiction of the Environmental Division of the Franklin County Municipal Court pursuant to O.R.C. §1901.181.

PARTIES

- 2. Relator-Plaintiff Zach Klein is the duly-elected, sworn, and acting City Attorney for the City of Columbus, Ohio and is a party charged by R.C. §§ 713.13, 715.30, 3767.03, 3767.41; C.C.C. §§101.08, 4701.08; and at common law with the prevention, prosecution, and abatement of any public nuisance within the City of Columbus, Franklin County, Ohio.
- 3. The real property that is the subject matter of this complaint is located at 5200 Riding Club Lane, Columbus, Ohio 43213, known as Franklin County Permanent Parcel No. 010-201156 (hereinafter "the Premises"), situated in the City of Columbus, Franklin County, Ohio. (See Plaintiff's Exhibit A.) This action is also *in rem* with respect to the Premises.
- 4. PKWY Lounge and Grill (hereinafter "PKWY") is an Ohio business operating as a bar, club, and restaurant at the Premises, and is owned and operated by John Delia and Asia Majors.
- 5. 1714 Zettler LLC is an Ohio corporation which had operated a bar at the Premises formerly known as Atlantis Grill & Sports Bar aka Parkview Bar. 1714 Zettler LLC is also an owner of the Premises by virtue of its ownership of the now-expired Liquor Permit No. 6548277, which had been issued for the operation of liquor sales at the Premises. This permit was cancelled by the Division of Liquor Control on May 4, 2022, for failure to resolve tax issues with the Division, thus revoking the permit. (*See Plaintiff's Exhibits B & C.*) There is no current liquor permit issued to the Premises. Prior to this rejection, PKWY had operated illegally under this permit issued to 1714 Zettler LLC, and by virtue of this, 1714 Zettler LLC is an owner by virtue of its charge, care, and control.
- 6. John Delia is the owner of the Premises by virtue of his ownership of the business PKWY, his ownership of the now-expired liquor permit issued to 1714 Zettler LLC, and, upon information and belief, his having charge, care, and control of the Premises.
- 7. PKWY Lounge & Grill LLC is an Ohio corporation doing business as "PKWY Lounge & Grill" at the Premises, and is an owner with charge, care, and control by virtue of its June 2021 application to transfer a liquor permit for the sale of alcohol at the Premises (transfer Permit

No. 6726677). Relator-Plaintiff objected to this transfer. On May 4, 2022, the transfer was rejected for tax issues. PKWY Lounge & Grill LLC does not and has never had a liquor permit issued to the LLC or the Business, and, upon information and belief, it has operated to sell alcohol at the Premises previously illegally under a permit issued to 1714 Zettler LLC.

- 8. Denash Massage LLC is an Ohio corporation doing business as "PKWY Lounge & Grill" at the Premises, and is an owner with charge, care, and control by virtue of its December 2021 application to transfer a liquor permit for the sale of alcohol at the Premises (pending Permit No. 20138840005). Relator-Plaintiff objected to this transfer, and the objection is still pending. Denash Massage LLC does not and has never had a liquor permit issued to the LLC or the Business, and, upon information and belief, it has operated to sell alcohol at the Premises previously illegally under a permit issued to 1714 Zettler LLC.
- 9. 5600 Naiche LLC is the real property owner of the Premises, the property located at 5200 Riding Club Lane, Ohio 43213, and is an owner of the Premises as defined by C.C.C. 4703.01(E), by virtue of a Limited Warranty Deed, Instrument No. 201905030051780, filed with the Franklin County Recorder. (See Plaintiff's Exhibit D.) 5600 Naiche LLC shares a statutory agent and address with Respondent-Defendant 1714 Zettler LLC, the owner of the now-expired liquor permit. 5600 Naiche LLC is also an owner by virtue of its charge, care, and control of the Premises, which includes the bar-club-restaurant PKWY.
- 10. Wyandotte Athletic Club LLC is an interested party by virtue of its pending suit in the Franklin County Court of Common Pleas, Case No. 20CV000924, against 5600 Naiche LLC, an interest which may be adversely affected by this action.
- 11. NAR Ohio, LLC, is an interested party by virtue of its tax lien certificate in its favor against 5600 Naiche LLC, Instrument No. 202111100205925, filed with the Frankling County Recorder, which may be adversely affected by this action.

12. Cheryl Brooks Sullivan is the duly elected, sworn, and serving Treasurer of Franklin County, Ohio, and may claim an interest in the properties for unpaid and future taxes. This interest could be adversely affected by this action.

JURISDICTION & VENUE

- 13. The Court has personal jurisdiction over the individual defendants pursuant to O.R.C. §2307.382(A)(8), since the basis of this complaint is real property located in Franklin County, Ohio.
- 14. The Court is a proper venue pursuant to Civ.R. 3(B)(5), since the subject of the action is real property situated in Franklin County, Ohio.

FACTS

- 15. PKWY Lounge and Grill (formerly known as Atlantis Bar Grill and Sports Bar, and formerly known as Parkview Bar) is a bar, club, and/or restaurant operating at the Premises. PKWY has been operating at the location since at least 2019 under at least one of the aforementioned business names.
- 16. 5600 Naiche LLC has be the sole record owner of the Premises since May 3, 2019.
- 17. The Premises came to the attention of the Columbus Police Department ("CPD") in 2021.
- 18. Since February 2021, there have been over sixty (60) calls for service and/or reports taken
- by the Columbus Division of Police (CPD), at the Premises, including shootings, shots fired,
- fights/disturbances, stabbings, thefts from motor vehicles, criminal damaging, and loud noise.
- 19. On February 20, 2021, CPD was dispatched to the location on the report of multiple gun
- shots fired. Officers recovered multiple shell casings in the parking lot. A bullet entered an
- exterior wall of the bar and entered an interior bathroom. A vehicle was also struck by a bullet.
- The shots fired were the end result of a fight that began inside the bar.

- 20. On March 13, 2021, CPD was dispatched to the Premises on a report of several gun shots as a result of a fight inside and outside the bar. Two vehicles in the parking lot were struck by bullets. Officers recovered five shell casings in the parking lot.
- 21. On March 28, 2021, CPD was dispatched to the Premises when security located a handgun on a patron. While on scene, an unknown suspect fired gunshots in an adjacent parking lot used for bar parking. Shell casings were recovered by CPD.
- 22. On September 13, 2021, a women reported to CPD being assaulted inside by the bar, during which the suspect also reached for their firearm.
- 23. On December 12, 2021, a fight occurred in the parking lot of the Premises at the time of bar closing, during which two persons stabbed each other.
- 24. On January 23, 2022, a victim reported to CPD a fight at 5200 Riding Club involving gunshots, which officers in the area also heard. A witness stated a vehicle's passenger was also firing gunshots from a fleeing vehicle. The gun fire was believed to come from an automatic weapon. Two uninvolved vehicles were struck by a bullet during the incident. One of the vehicles had a 7 year old girl inside who was nearly struck by the bullet. A follow-up investigation determined that the suspects waited outside for people they were fighting inside the Premises.
- 25. On March 2, 2022, CPD was dispatched to the Premises on reports of a fight at the bar.
- 26. On March 6, 2022, CPD was dispatched to the Premises on reports of a group of at least ten (10) persons fighting in the parking lot outside the bar after 1:00 AM.
- 27. On March 19, 2022, CPD was dispatched to the Premises on reports of a group of at least five (5) persons fighting in the parking lot outside the bar.
- 28. On April 13, 2022, CPD was dispatched to the Premises on a report of a person inside the bar with a handgun.

- 29. On April 30, 2022, CPD arrested an individual for possession of a handgun inside the bar. The arrestee attempted to flee from officers during the arrest. The arrestee claimed he paid security officers at the bar \$200 to bring the gun inside the bar.
- 30. Also on April 30, 2022, CPD was dispatched to the Premises on the report of 6-7 gunshots fired at the bar.
- 31. On May 1, 2022, CPD was dispatched the Premises on reports of a large fight inside the bar.
- 32. Until May 4, 2022, the only liquor permit properly issued to the Premises was issued to 1714 Zettler LLC, doing business at Atlantis Grill & Sports Bar, Liquor Permit No. 6548277. Defendant John Delia was listed as the owner of this LLC for the purposes of the liquor permit issued to 1714 Zettler LLC.
- 33. Beginning in April 2021, the Division of Liquor Control opened a case against 1714 Zettler LLC's liquor permit (#6548277) for tax problems that could affect the ability to renew or transfer the permit. (See Exhibit E.)
- 34. In June 2021, PKWY Lounge & Grill applied for a transfer of the liquor permit issued to 1714 Zettler LLC, transfer permit number 6726677. The City of Columbus subsequently objected to this permit transfer. With a hearing still pending, the permit transfer request was rejected due to tax issues with the original permit issued to 1714 Zettler LLC.
- 35. PKWY Lounge & Grill LLC does not and has never had a liquor permit issued to the LLC or the Business, and, upon information and belief, it has operated to sell alcohol at the Premises previously illegally under a permit issued to 1714 Zettler LLC.
- 36. On September 30, 2021, the Liquor Control Commission received an appeal of the tax case, the decision for which was stayed the same day. (*See Exhibit E.*)

- 37. On November 18, 2021, the Division of Liquor Control reaffirmed continued outstanding tax issues for 1714 Zettler LLC that could affect the ability to renew or transfer the permit. (See Exhibit E.)
- 38. In December 2021, Denash Massage LLC applied for a transfer of the liquor permit issued to 1714 Zettler LLC, pending permit number 20138840005. The City of Columbus subsequently objected to this permit transfer, and the objection is still pending.
- 39. Denash Massage LLC does not and has never had a liquor permit issued to the LLC or the Business, and, upon information and belief, it has operated to sell alcohol at the Premises previously illegally under a permit issued to 1714 Zettler LLC.
- 40. In December 2021, the City of Columbus objected to the renewal of the liquor permit issued at the Premises to 1714 Zettler LLC.
- 41. On February 10, 2022, 1714 Zettler LLC received notice from the Division of Liquor Control that its 2022-2023 Liquor Permit Renewal Application would not be issued until the resolution of the outstanding tax issues, which include tax delinquency, liability and/or assessments. (*See Exhibit C.*)
- 42. The Division served this letter on 1714 Zettler LLC on February 17, 2022, and PKWY continued to sell alcohol at the Premises. (*See Exhibit C.*)
- 43. 1714 Zettler LLC did not appeal this non-renewal order by the time stated in the order—May 2, 2022.
- 44. Thus, on May 4, 2022, the Division of Liquor Control rejected the 2022-2023 renewal of the liquor permit issued to 1714 Zettler LLC (#6548277) that was in use for liquor sales at the Premises. As a result, the Division closed its case against this permit and permitholder, and rejected the transfer request of PKWY Lounge & Grill LLC. (See Exhibits C, D, E.)
- 45. As of May 4, 2022, there are no active liquor permits issued to the Premises, to 1714 Zettler LLC, to PWKY Lounge & Grill LLC, to Denash Message LLC, or any other person for

possible use at this Premises. Liquor sales are thus prohibited at the Premises until a new liquor permit is obtained.

- 46. Upon information and belief, PKWY has continued to operate the business, including liquor sales, and CPD opened an investigation in conjunction with the Ohio Investigative Unit. 47. On May 5, 2022, PKWY Lounge Instagram page "pkwy_loungecolumbus_" advertised an event for May 27, 2022, called "Sleazy World Go" performing live with ticket sales through Eventbrite. (*See Exhibit F.*)
- 48. On May 6, 2022, CPD officers of the PACT unit covertly purchased beer and intoxicating liquor at the Premises. Prior to the covert purchase, PKWY had advertised that there would be a special event with performers that same evening. Officers observed the bar having beer and intoxicating liquor bottles on the shelves behind the bar, for sale.
- 49. On May 9, 2022, PKWY Lounge Instagram page "pkwy_loungecolumbus_" advertised an event for May 20, 2022, called "Hennessy Carolina". (See Exhibit G.)
- 50. On May 10, 2022, CPD officers of the PACT unit entered the Premises after witnessing an ad on Instagram advertising "Cameo Tuesday's" and "Buy one, get one free Hennessy and Tito's from 8PM to 11PM." Officers covertly purchased beer and intoxicating liquor from the Premises that evening. Officers witnessed the bartender pour the Tito's Vodka from the bottle. Officers observed the bartender take the 12 oz. commercially bottled Corona Extra beer from the cooler and remove the lid.
- 51. On May 14, 2022, PACT officers witnessed an Instagram advertisement posted on May 11, 2022, by PKWY Lounge, 5200 Riding Club Lane, stating "MEGA Saturday's" with doors opening at 10PM. Officers arrived at approximately 10:15PM but found the location closed. Upon investigation, your affiant learned the location was vandalized on May 12, 2022 and the gas and water lines were damaged. Columbus Fire responded to scene and shut off the gas. As

- of filing, tickets were still being sold for on Eventbrite for May 27, 2022 from 9PM-2AM, "Sleazy World Go." The event is 21 years old and older. (See Exhibit G.)
- 52. On May 15, 2022, PKWY Lounge Instagram page "pkwy_loungecolumbus_" posted again an advertisement, "Hennesy Carolina," at 5200 Riding Club Lane, with doors opening at 8PM on Friday, May 20-2022. (See Exhibit G.)
- 53. PKWY continues to advertise events, including for concerts on May 20 and May 27, 2022, and their "Cameo Tuesday's" posts reference that they have these specials "each and every Tuesday." (See Exhibit G.)
- 54. The Premises is a public nuisance as defined in R.C. § 3767.01 and/or R.C. § 3767.12 (et seq), C.C.C. § 4703.01(F), and under common law, subject to abatement under R.C. § 3767.
- 55. The Premises is generally reputed to be kept, conducted, and/or maintained for the purposes of committing violations of Ohio Revised Code Chapter 3767 (Nuisance), Chapter 4301 (Liquor Control) and Columbus City Code Title 47, and other violent crimes and illegal activity.
- 56. Defendants, except those named solely as interested parties, are guilty of maintaining a nuisance at the Premises, subject to abatement in accordance with R.C. 3767.01 (et seq.), for having a structure in violation of the laws pertaining to the illegal sale of alcohol without a liquor permit (including violations of R.C. §§ 4301, 4303, and 4399), for operating a business in violation of the laws pertaining to violent activity, and the permission or existence of this criminal activity at the Premises substantially interferes with the area's public decency, sobriety, peace, safety, welfare, and good order.
- 57. The operation of 5200 Riding Club Lane has caused an increase in criminal and nuisance activity within the surrounding community, and continued operation at the subject Premises imposes imminent threat to the life, health, and safety of the area community.

- 58. Defendants own fixtures, furniture, and moveable property, including alcohol purchased for the purpose of illegal sales, which have been used in conducting, maintaining and facilitating said public nuisance.
- 59. Defendants at all times relevant to this action maintained a public nuisance threatening the health, safety, and welfare of the People of the City of Columbus, those at 5200 Riding Club Lane, and that of the Columbus Police.
- 60. Defendants, except those named solely as interested parties, are guilty of maintaining a nuisance at the Premises based on their actual and constructive knowledge of the nuisance, as well as the well-known general reputation of the Premises, which is prima-facie evidence of the nuisance and Defendants knowledge of and acquiescence and/or participation in the nuisance.

<u>COUNT I: O.R.C. TITLE 43 – LIQUOR LAW</u>

- 61. Paragraphs 1 through 60 of this Complaint are incorporated by reference as if fully rewritten herein.
- 62. Defendants do not possess a valid liquor permit for the sale or distribution of liquor (including but not limited to beer, wine, and spirituous liquor) at the Premises.
- 63. Defendants have violated R.C. §§ 4301.22, 4301.58, 4303 (et seq.), 4399.09(A), by selling and/or distributing liquor without a permit, and continue to advertise its intent to do so in the future.

COUNTS II & III: O.R.C. TITLE 37; C.C.C. TITLE 47 – NUISANCE ABATEMENT

- 64. Paragraphs 1 through 63 of this Complaint are incorporated by reference as if fully rewritten herein.
- 65. The Premises is a public nuisance as defined by C.C.C. § 4703.01(F), O.R.C. §§ 2923.43, 3719.10. 3767.01, 3767.12, and/common law.

- 66. The Premises is subject to abatement pursuant to C.C.C. § 4701.08, O.R.C. Chapter 3767, and/or common law.
- 67. Respondents-Defendants are guilty of maintaining a public nuisance at the Premises pursuant to O.R.C. § 3767.02.
- 68. Respondents-Defendants are further guilty of maintaining a public nuisance at the Premises based on their actual and constructive knowledge of the public nuisance at the Premises based on their actual and constructive knowledge of the public nuisance, as well as the general reputation of the Premises, which is prima-facie evidence of the nuisance and of knowledge of and of acquiescence and/or participation in the public nuisance.
- 69. Respondents-Defendants (except those named only as interested parties) own fixtures, furniture, and moveable property, including alcohol purchased for the purpose of illegal sales, which have been used in conducting, maintaining and facilitating said public nuisance.
- 70. Defendants at all times relevant to this action maintained a public nuisance threatening the health, safety, and welfare of the People of the City of Columbus, those at 5200 Riding Club Lane, and that of the Columbus Police.

COUNT IV: COMMON LAW NUISANCE

- 71. Paragraphs 1 through 70 of this Complaint are incorporated by reference as if fully rewritten herein.
- 72. The Premises is a public nuisance as defined by the common law of the State of Ohio.

JUDGMENT AND RELIEF DEMANDED

WHEREFORE, Plaintiff demands judgment as follows:

1. Relator-Plaintiff incorporates the proceeding paragraphs 1 through 72 as if fully incorporated herein.

Compliance with Liquor Law

- 2. An order requiring the defendant(s) and any successor(s) in interest or title to comply with Title 43 of the Ohio Revised Code, specifically, adherence to any and all State Liquor Laws.
- 3. An order requiring defendant(s) to take measures included, but not limited to, the following in order to ensure ongoing compliance with Title 43:
 - a. Prohibition of any liquor (to include beer, wine, and spirituous liquor) at the Premises;
 - b. Prohibition of any liquor sales at the Premises;
 - c. Seizure of any alcohol intended for sale;
 - d. Limit the Premises' days and hours of operation;
 - e. Closure of the Premises.

Criminal Activity

- 1. The Court set a preliminary injunction hearing on the matter pursuant to Ohio Civ.R. 65(B)(1).
- A determination that the Premises constitutes and be declared a public nuisance as defined by C.C.C. § 4703.01(F), R.C. O.R.C. §§ 2923.43, 3719.10. 3767.01, 3767.12, and/or common law.
- 3. A determination that the Premises is subject to abatement under C.C.C. § 4701.08, O.R.C. Chapter 3767, and/or common law.
- 4. That Defendants (except for those named only as interested parties) be found guilty of maintaining a public nuisance at the Premises.
- 5. That Defendants (except for those named only as interested parties), and any heirs successors in interest or title, transferees and/or assigns be preliminarily, permanently, and perpetually enjoined from conducting, maintaining, using, occupying or in any way permitting the use of the Premises as a public nuisance.

- 6. That Defendants (except for those named only as interested parties) be preliminarily, permanently, and perpetually enjoined from conducting, maintaining, using, occupying or in any way permitting the use of a public nuisance anywhere in Franklin County, Ohio and/or Columbus, Ohio.
- 7. The Court order, pursuant to ORC 3767.06(A), that Respondents-Defendants (except for those named only as interested parties) abate the public nuisance located at the Premises.
- 8. The Court order, pursuant to ORC §3767.05(E)(3) that the Premises not be occupied or used for one year after the judgment is rendered.
- 9. The Court order, pursuant to ORC 3767.06(A), that the Premises be closed against its use for any purpose for a period of one year.
- 10. The Court order, pursuant to ORC 3767.06(A), that all personal property and contents used in conducting or maintaining the public nuisance at the Premises, including any liquor at the Premises, be removed, and sold, without appraisal, at a public auction to the highest bidder for cash.
- 11. That the Court tax Respondents-Defendants (except for those named only as interested parties) \$300 in accordance with Revised Code §3767.08, plus the costs of this action.

Criminal Activity - Liquor Law

- 1. The Court specifies that its judgment is entered pursuant to ORC 3767.05(E).
- 2. The Court order, pursuant to ORC 3767.05(E)(2), that no beer or intoxicating liquor may be manufactured, sold, bartered, possessed, kept, or stored at the Premises.
- 3. The Court order, pursuant to ORC 3767.05(E)(4), that notice of its judgment be sent to the Ohio Division of Liquor Control, the Ohio Liquor Control Commission, and the Liquor Enforcement Division of the Ohio Department of Public Safety.
- 4. The Court order, pursuant to ORC 3767.05(G), that a certified copy of its judgment be filed with the Franklin County Board of Elections.

Additional Relief

- 1. An award of Plaintiff's costs and attorney's fees payable by defendant(s).
- 2. The Court grant Relator-Plaintiff all such further equitable and other relief this Court determines Relator-Plaintiff to be entitled pursuant to ORC 1901.131, and by law.

ATTORNEY'S CERTIFICATION, CIVIL RULE 65

Assistant City Attorney Sarah C. Pomeroy, attorney for Relator-Plaintiff State Ex Rel Columbus City Attorney Zach Klein, pursuant to Civil Rule 65, hereby certifies the following:

- 1. No attempts have been made to notify Respondents-Defendants of this motion for an *ex* parte temporary restraining order.
- 2. Notice of this Motion for an *ex parte* temporary restraining order should not be required because:
- 3. 5200 Riding Club Lane, Parcel No. 010-201156, Columbus, Ohio ("the Premises") came to the attention of the Columbus Police Department ("CPD") in 2021.
- 4. The Premises is a bar, club, and restaurant venue located on the East side of Columbus.
- 5. Since February 2021, there have been over sixty (60) calls for service and/or reports taken by the Columbus Division of Police (CPD), at the Premises, including shootings, shots fired, fights/disturbances, stabbings, thefts from motor vehicles, criminal damaging, and loud noise.
- 6. On February 20, 2021, CPD was dispatched to the location on the report of multiple gun shots fired. Officers recovered multiple shell casings in the parking lot. A bullet entered

- an exterior wall of the bar and entered an interior bathroom. A vehicle was also struck by a bullet. The shots fired were the end result of a fight that began inside the bar.
- 7. On March 13, 2021, CPD was dispatched to the Premises on a report of several gun shots as a result of a fight inside and outside the bar. Two vehicles in the parking lot were struck by bullets. Officers recovered five shell casings in the parking lot.
- 8. On March 28, 2021, CPD was dispatched to the Premises when security located a handgun on a patron. While on scene, an unknown suspect fired gunshots in an adjacent parking lot used for bar parking. Shell casings were recovered by CPD.
- 9. On September 13, 2021, a women reported to CPD being assaulted inside by the bar, during which the suspect also reached for their firearm.
- 10. On December 12, 2021, a fight occurred in the parking lot of the Premises at the time of bar closing, during which two persons stabbed each other.
- 11. On January 23, 2022, a victim reported to CPD a fight at 5200 Riding Club involving gunshots, which officers in the area also heard. A witness stated a vehicle's passenger was also firing gunshots from a fleeing vehicle. The gun fire was believed to come from an automatic weapon. Two uninvolved vehicles were struck by a bullet during the incident. One of the vehicles had a 7 year old girl inside who was nearly struck by the bullet. A follow-up investigation determined that the suspects waited outside for people they were fighting inside the Premises.
- 12. On March 2, 2022, CPD was dispatched to the Premises on reports of a fight at the bar.
- 13. On March 6, 2022, CPD was dispatched to the Premises on reports of a group of at least ten (10) persons fighting in the parking lot outside the bar after 1:00 AM.
- 14. On March 19, 2022, CPD was dispatched to the Premises on reports of a group of at least five (5) persons fighting in the parking lot outside the bar.

- 15. On April 13, 2022, CPD was dispatched to the Premises on a report of a person inside the bar with a handgun.
- 16. On April 30, 2022, CPD arrested an individual for possession of a handgun inside the bar.

 The arrestee attempted to flee from officers during the arrest. The arrestee claimed he paid security officers at the bar \$200 to bring the gun inside the bar.
- 17. Also on April 30, 2022, CPD was dispatched to the Premises on the report of 6-7 gunshots fired at the bar.
- 18. On May 1, 2022, CPD was dispatched the Premises on reports of a large fight inside the bar.
- 19. Until May 4, 2022, the only liquor permit properly issued to the Premises was issued to 1714 Zettler LLC, doing business at Atlantis Grill & Sports Bar, Liquor Permit No. 6548277. Defendant John Delia was listed as the owner of this LLC for the purposes of the liquor permit issued to 1714 Zettler LLC.
- 20. Beginning in April 2021, the Division of Liquor Control opened a case against 1714 Zettler LLC's liquor permit (#6548277) for tax problems that could affect the ability to renew or transfer the permit. (See Complaint Exhibit E.)
- 21. In June 2021, PKWY Lounge & Grill applied for a transfer of the liquor permit issued to 1714 Zettler LLC, transfer permit number 6726677. The City of Columbus subsequently objected to this permit transfer. With a hearing still pending, the permit transfer request was rejected due to tax issues with the original permit issued to 1714 Zettler LLC.
- 22. PKWY Lounge & Grill LLC does not and has never had a liquor permit issued to the LLC or the Business, and, upon information and belief, it has operated to sell alcohol at the Premises previously illegally under a permit issued to 1714 Zettler LLC.
- 23. On September 30, 2021, the Liquor Control Commission received an appeal of the tax case, the decision for which was stayed the same day. (See Complaint Exhibit E.)

- 24. On November 18, 2021, the Division of Liquor Control reaffirmed continued outstanding tax issues for 1714 Zettler LLC that could affect the ability to renew or transfer the permit. (See Complaint Exhibit E.)
- 25. In December 2021, Denash Massage LLC applied for a transfer of the liquor permit issued to 1714 Zettler LLC, pending permit number 20138840005. The City of Columbus subsequently objected to this permit transfer, and the objection is still pending.
- 26. Denash Massage LLC does not and has never had a liquor permit issued to the LLC or the Business, and, upon information and belief, it has operated to sell alcohol at the Premises previously illegally under a permit issued to 1714 Zettler LLC.
- 27. In December 2021, the City of Columbus objected to the renewal of the liquor permit issued at the Premises to 1714 Zettler LLC.
- 28. On February 10, 2022, 1714 Zettler LLC received notice from the Division of Liquor Control that its 2022-2023 Liquor Permit Renewal Application would not be issued until the resolution of the outstanding tax issues, which include tax delinquency, liability and/or assessments. (See Complaint Exhibit C.)
- 29. The Division served this letter on 1714 Zettler LLC on February 17, 2022, and PKWY continued to sell alcohol at the Premises. (See Complaint Exhibit C.)
- 30. 1714 Zettler LLC did not appeal this non-renewal order by the time stated in the order—May 2, 2022.
- 31. Thus, on May 4, 2022, the Division of Liquor Control rejected the 2022-2023 renewal of the liquor permit issued to 1714 Zettler LLC (#6548277) that was in use for liquor sales at the Premises. As a result, the Division closed its case against this permit and permitholder, and rejected the transfer request of PKWY Lounge & Grill LLC. (See Complaint Exhibits C, D, E.)

- 32. As of May 4, 2022, there are no active liquor permits issued to the Premises, to 1714 Zettler LLC, to PWKY Lounge & Grill LLC, to Denash Message LLC, or any other person for possible use at this Premises. Liquor sales are thus prohibited at the Premises until a new liquor permit is obtained.
- 33. Upon information and belief, PKWY has continued to operate the business, including liquor sales, and CPD opened an investigation in conjunction with the Ohio Investigative Unit.

Prior to the covert purchase, PKWY had advertised that there would be a special event with performers that same evening. Officers observed the bar having beer and intoxicating liquor bottles on the shelves behind the bar, for sale.
- 36. On May 9, 2022, PKWY Lounge Instagram page "pkwy_loungecolumbus_" advertised an event for May 20, 2022, called "Hennessy Carolina". (See Complaint Exhibit G.)
- 37. On May 10, 2022, CPD officers of the PACT unit entered the Premises after witnessing an ad on Instagram advertising "Cameo Tuesday's" and "Buy one, get one free Hennessy and Tito's from 8PM to 11PM." Officers covertly purchased beer and intoxicating liquor from the Premises that evening. Officers witnessed the bartender pour the Tito's Vodka from the bottle. Officers observed the bartender take the 12 oz. commercially bottled Corona Extra beer from the cooler and remove the lid.
- 38. On May 14, 2022, PACT officers witnessed an Instagram advertisement posted on May 11, 2022, by PKWY Lounge, 5200 Riding Club Lane, stating "MEGA Saturday's" with doors opening at 10PM. Officers arrived at approximately 10:15PM but found the location

closed. Upon investigation, your affiant learned the location was vandalized on May 12, 2022 and the gas and water lines were damaged. Columbus Fire responded to scene and shut off the gas. As of filing, tickets were still being sold for on Eventbrite for May 27, 2022 from 9PM-2AM, "Sleazy World Go." The event is 21 years old and older. (See Complaint Exhibit G.)

- 39. On May 15, 2022, PKWY Lounge Instagram page "pkwy_loungecolumbus_" posted again an advertisement, "Hennesy Carolina," at 5200 Riding Club Lane, with doors opening at 8PM on Friday, May 20, 2022. (See Complaint Exhibit G.)
- 40. PKWY continues to advertise events, including for concerts on May 20 and May 27, 2022, and their "Cameo Tuesday's" posts reference that they have these specials "each and every Tuesday." (See Complaint Exhibit G.)
- 41. The Premises, and specifically the violent crime and illegal liquor sales at the property, constitute an imminent danger for those at the property and for those around the property.
- 42. Defendants plan to host additional events in the coming week, in which it is highly probably they will sell and/or distribute liquor, despite its failure to obtain a valid liquor permit from the State of Ohio, Division of Liquor Control.
- 43. Failing to immediately padlock the property after the execution of the *ex parte* temporary restraining order will allow the dangerous illegal activity to continue, thereby causing immediate and irreparable injury, loss or damage to Defendants and the community.
- 44. *Ex parte* closure of the property is necessary in order to prevent destruction or removal of contraband or other property.
- 45. Failure to issue a temporary restraining order to prohibit the presence, sale, and/or distribution of liquor at the Premises, until further Order of this Court, will allow the illegal liquor sales to continue and to be amplified through the events planned for the upcoming week. This blatant disregard for the law will occur but for an Order from

this Court. The sale of liquor at the Premises without a permit will result in immediate and irreparable injury, loss, and damage to the Plaintiff and thus the community.

46. Ex parte orders governing the sale of liquor at the property is necessary in order to prevent the sale and/or distribution of liquor at events planned at the Premises this upcoming week.

47. Prior notification of the temporary restraining order could pose a danger to the physical safety and lives of the Columbus Police officers involved in its execution.

48. The property rights of Defendants will be sufficiently protected in that they will be notified in advance of the hearing for Preliminary Injunctive Relief that will be held within roughly ten (10) days after issuing the *ex parte* Temporary Restraining Order.

Affidavit of Sergeant Stephen Oboczky, Columbus Police Department:

Now comes Sergeant Stephen Oboczky, Columbus Police Department having been duly cautioned and sworn who says:

- 1. I am a Sergeant the Police and Community Together (PACT) Unit of the Columbus Police Department, and I am tasked with, in part, investigating and enforcing the Liquor Laws of the State of Ohio, as well as investigating criminal activity at liquor-permitted establishments in the City of Columbus.
- 2. 5200 Riding Club Lane, Parcel No. 010-201156, Columbus, Ohio ("the Premises") came to the attention of the Columbus Police Department ("CPD") in 2021.

- 28. On February 10, 2022, 1714 Zettler LLC received notice from the Division of Liquor Control that its 2022-2023 Liquor Permit Renewal Application would not be issued until the resolution of the outstanding tax issues, which include tax delinquency, liability and/or assessments.
- 29. The Division served this letter on 1714 Zettler LLC on February 17, 2022, and PKWY continued to sell alcohol at the Premises.
- 30. 1714 Zettler LLC did not appeal this non-renewal order by the time stated in the order—May 2, 2022.
- 31. Thus, on May 4, 2022, the Division of Liquor Control rejected the 2022-2023 renewal of the liquor permit issued to 1714 Zettler LLC (#6548277) that was in use for liquor sales at the Premises. As a result, the Division closed its case against this permit and permitholder, and rejected the transfer request of PKWY Lounge & Grill LLC.
- 32. As of May 4, 2022, there are no active liquor permits issued to the Premises, to 1714 Zettler LLC, to PWKY Lounge & Grill LLC, to Denash Message LLC, or any other person for possible use at this Premises. Liquor sales are thus prohibited at the Premises until a new liquor permit is obtained.
- 33. Upon information and belief, PKWY has continued to operate the business, including liquor sales, and CPD opened an investigation in conjunction with the Ohio Investigative Unit.
- 34. On May 5, 2022, PKWY Lounge Instagram page "pkwy_loungecolumbus_" advertised an event for May 27, 2022, called "Sleazy World Go" performing live with ticket sales through Eventbrite.

- 35. On May 6, 2022, CPD officers of the PACT unit covertly purchased beer and intoxicating liquor at the Premises. Prior to the covert purchase, PKWY had advertised that there would be a special event with performers that same evening. Officers observed the bar having beer and intoxicating liquor bottles on the shelves behind the bar, for sale.
- 36. On May 9, 2022, PKWY Lounge Instagram page "pkwy_loungecolumbus_" advertised an event for May 20, 2022, called "Hennessy Carolina".
- 37. On May 10, 2022, CPD officers of the PACT unit entered the Premises after witnessing an ad on Instagram advertising "Cameo Tuesday's" and "Buy one, get one free Hennessy and Tito's from 8PM to 11PM." Officers covertly purchased beer and intoxicating liquor from the Premises that evening. Officers witnessed the bartender pour the Tito's Vodka from the bottle. Officers observed the bartender take the 12 oz. commercially bottled Corona Extra beer from the cooler and remove the lid.
- 38. On May 14, 2022, PACT officers witnessed an Instagram advertisement posted on May 11, 2022, by PKWY Lounge, 5200 Riding Club Lane, stating "MEGA Saturday's" with doors opening at 10PM. Officers arrived at approximately 10:15PM but found the location closed. Upon investigation, your affiant learned the location was vandalized on May 12, 2022 and the gas and water lines were damaged. Columbus Fire responded to scene and shut off the gas. As of filing, tickets were still being sold for on Eventbrite for May 27, 2022 from 9PM-2AM, "Sleazy World Go." The event is 21 years old and older.
- 39. On May 15, 2022, PKWY Lounge Instagram page "pkwy_loungecolumbus_" posted again an advertisement, "Hennesy Carolina," at 5200 Riding Club Lane, with doors opening at 8PM on Friday, May 20, 2022.
- 40. PKWY continues to advertise events, including for concerts on May 20 and May 27, 2022, and their "Cameo Tuesday's" posts reference that they have these specials "each and every Tuesday."

- 41. The Premises, and specifically the violent crime and illegal liquor sales at the property, constitute an imminent danger for those at the property and for those around the property.
- 42. Defendants plan to host additional events in the coming week, in which it is highly probably they will sell and/or distribute liquor, despite its failure to obtain a valid liquor permit from the State of Ohio, Division of Liquor Control.
- 43. Failing to immediately padlock the property after the execution of the *ex parte* temporary restraining order will allow the dangerous illegal activity to continue, thereby causing immediate and irreparable injury, loss or damage to Defendants and the community.
- 44. *Ex parte* closure of the property is necessary in order to prevent destruction or removal of contraband or other property.
- 45. Failure to issue a temporary restraining order to prohibit the presence, sale, and/or distribution of liquor at the Premises, until further Order of this Court, will allow the illegal liquor sales to continue and to be amplified through the events planned for the upcoming week. This blatant disregard for the law will occur but for an Order from this Court. The sale of liquor at the Premises without a permit will result in immediate and irreparable injury, loss, and damage to the Plaintiff and thus the community.
- 46. Ex parte orders governing the sale of liquor at the property is necessary in order to prevent the sale and/or distribution of liquor at events planned at the Premises this upcoming week.
- 47. Prior notification of the temporary restraining order could pose a danger to the physical safety and lives of the Columbus Police officers involved in its execution.
- 48. The property rights of Defendants will be sufficiently protected in that they will be notified in advance of the hearing for Preliminary Injunctive Relief that will be held within roughly ten (10) days after issuing the *ex parte* Temporary Restraining Order.

City's Exhibite A- Game admitted.

Relator-Plaintiff has established by clear and convincing evidence that the liquor violations, violent crimes, and illegal/unsafe activity occurring at the Premises—in violation of O.R.C. Titles 37 and 43 and C.C.C. Title 47—continue to cause irreparable harm to the community. Respondents-Defendants have violated provisions of O.R.C. §§ 4301.22, 4301.58, 4303 (et seq.), 4399.09(A) in continuing to sell liquor without a valid permit; and that the property is a nuisance per se as defined in O.R.C. § 3719.10 and § 3767.01, and C.C.C. § 4703.01.

It is further **ORDERED** that all persons are hereby preliminarily enjoined from further maintaining a public nuisance at or on the Premises.

It is further **ORDERED** that the Premises located at 5200 Riding Club Lane in its entirety, including all structures, buildings, curtilage, parking lot areas and/or enclosures, shall be closed, padlocked, boarded or secured as deemed necessary by the Chief of the Columbus Police Department or his or her designee(s) against its use for any purpose until a final decision is rendered on the Complaint for Preliminary and Permanent Injunctive Relief as required by O.R.C. § 3767.04. Board-up of the Premises shall be executed by close-of-business on May 17, 2022.

It is further **ORDERED** that all occupants of the Premises be forcibly removed from the Premises forthwith. In executing this order, all barricades throughout the structure may be forcibly removed so as to prevent fortifying portions of the business. Said occupants may be forcibly detained during the execution of this order.

It is further **ORDERED** that the Columbus Police is authorized to seize and inventory any and all personal property located in 5200 Riding Club Lane related to or in connection with the illegal conduct, including but not limited to any beer or intoxicating liquor stored at the Premises. The Columbus Division of Police may also remove and secure at an off-site location highly mobile

and valuable property, including but not limited to such personal property as automobiles, cash, jewelry, and electronic equipment which may be at risk of theft during the pendency of this Order.

It is further **ORDERED** that there shall not be any liquor (to include beer, wine, and spirituous liquor) present at the Premises until further order of this Court. Furthermore, there shall be no sale or distribution of any liquor (to include beer, wine, and spirituous liquor) at the Premises until further order of this Court.

Any violation of this order, including mutilation of this order, is contempt of court, punishable as a first degree misdemeanor.

This case is continued for further preliminary hearing on the merits of Plaintiff's Complaint for Preliminary and Permanent Injunctive Relief on the day of May, 2022 at A.M./P.M. in courtroom 15B, located on the 15th floor of 375 S. High Street, Columbus, Ohio 43215. This Order shall remain in effect until that time or as otherwise ordered by this Court.

This order shall be served upon the Respondents-Defendants by the Columbus Division of Police or Relator-Plaintiff's Counsel; the order may be served by posting a copy of it in a conspicuous place at or upon one or more of the principal doors or entrances of the property. The closing of said Premises with forcible entry and removal of all occupants shall be effectuated by the Columbus Division of Police with the assistance of Columbus Code Enforcement. Based on the Affidavit submitted with the Complaint and Motion, the Court finds that notice of entry upon the Premises could result in destruction, concealment or removal of contraband, liquor, or property and could create a serious risk of physical harm to law enforcement officers or other authorized individuals in the execution of this *ex parte* Order.

IT IS SO ORDERED.
