	I Deputy Carver (6617) accompanied by a Pike Co Undercover Agent led the Portsmouth PD SWAT Team and others to the location. Portsmouth PD SWAT were doing the initial entrance into the home. The Undercover Agent and I went to the back of the property and cleared a tent that was set up. I also held the back of the property until all areas were said to be made safe by all Officers. I also helped to clear a crawl space that was underneath the home with an open area in the back. I found that the tent and the crawl space were clear from anyone being inside. I also had dispatch run a vehicle was that was on the property which was a 2001 Chevy Tahoe to see if it was reported stolen due to the damage it had. The vehicle was found not to have been stolen. After the property was secured the property began to be searched for the reasons on the search warrant. Piketon Police K9 handler Officer Daniel Spires (P7) and K9 Lana began to go through parts of the property to see if there were any positive indications of illegal substance. K9 Lana did indicate in one of the back bedrooms as well as inside the kitchen of the home. Other Deputies from the Pike Co Sheriff's Office conducted the search and logging of the evidence that was located. I cleared the scene while other Deputies remained on scene collecting evidence.
