INDICTMENT

State of Ohio,
Madison County, ss:

In the term beginning in January in the year of our Lord, two thousand and twenty-two, the jurors of the Grand Jury of Madison County, Ohio, within and for the body of the county aforesaid, on their oaths and in the name and by the authority of the State of Ohio, do find and present in Counts I, II, III, IV, V, VI, VII, VIII, and IX, of this Indictment that:

COUNT I
(Rape, F1)

On or between August 1, 2000 and December 15, 2000, in Madison County, Ohio, or whereby venue is properly placed in Madison County, Ohio, the defendant, Joel T. Cutler, did engage in sexual conduct with another; to-wit: E.B., who is not the spouse of the offender, when the other person is less than 13 years of age; to-wit: 12 years of age, whether or not the offender knows the age of the other person, in violation of §2907.02(A)(1)(b) of the Ohio Revised Code and against the peace and dignity of the State of Ohio.

COUNT II
(Rape, F1)

On or between August 1, 2000 and December 15, 2000, in Madison County, Ohio, the defendant, Joel T. Cutler, did engage in sexual conduct with another; to-wit: E.B., who is not the spouse of the offender, when the other

person is less than 13 years of age; to-wit: 12 years of age, whether or not the offender knows the age of the other person, in violation of §2907.02(A)(1)(b) of the Ohio Revised Code and against the peace and dignity of the State of Ohio.

COUNT III
(Sexual battery, F3)

On or between December 16, 2000 and June 7, 2001, in Madison County, Ohio, or whereby venue is properly placed in Madison County, Ohio, the defendant, Joel T. Cutler, did engage in sexual conduct with another; to-wit: E.B., not the spouse of the offender, when the offender is a teacher, administrator, coach, or other person in authority employed by or serving in a school for which the state board of education prescribes minimum standards pursuant to division (D) of section 3301.07 of the Revised Code, the other person is enrolled in or attends that school, and the offender is not enrolled in and does not attend that school, in violation of §2907.03(A)(7) of the Ohio Revised Code and against the peace and dignity of the State of Ohio.

COUNT IV
(Sexual battery, F3)

On or between December 16, 2000 and June 7, 2001, in Madison County, Ohio, the defendant, Joel T. Cutler, did engage in sexual conduct with another; to-wit: E.B., not the spouse of the offender, when the offender is a teacher, administrator, coach, or other person in authority employed by or serving in a school for which the state board of education prescribes minimum standards pursuant to division (D) of section 3301.07 of the Revised Code, the other person is enrolled in or attends that school, and the offender is not enrolled in

and does not attend that school, in violation of §2907.03(A)(7) of the Ohio Revised Code and against the peace and dignity of the State of Ohio.

COUNT V
(Sexual battery, F3)

On or between June 8, 2001 and June 7, 2002, in Madison County, Ohio, or whereby venue is properly placed in Madison County, Ohio, the defendant, Joel T. Cutler, did engage in sexual conduct with another; to-wit: E.B., not the spouse of the offender, when the offender is a teacher, administrator, coach, or other person in authority employed by or serving in a school for which the state board of education prescribes minimum standards pursuant to division (D) of section 3301.07 of the Revised Code, the other person is enrolled in or attends that school, and the offender is not enrolled in and does not attend that school, in violation of §2907.03(A)(7) of the Ohio Revised Code and against the peace and dignity of the State of Ohio.

COUNT VI
(Sexual battery, F3)

On or between June 8, 2001 and June 7, 2002, in Madison County, Ohio, the defendant, Joel T. Cutler, did engage in sexual conduct with another; to-wit: E.B., not the spouse of the offender, when the offender is a teacher, administrator, coach, or other person in authority employed by or serving in a school for which the state board of education prescribes minimum standards pursuant to division (D) of section 3301.07 of the Revised Code, the other person is enrolled in or attends that school, and the offender is not enrolled in and does not attend that school, in violation of §2907.03(A)(7) of the Ohio Revised Code and against the peace and dignity of the State of Ohio.

COUNT VII
(Unlawful sexual conduct with a minor, F3)

On or between June 7, 2002 and June 8, 2002, in Madison County, Ohio, the defendant, Joel T. Cutler, being a person who is eighteen years of age or older, did engage in sexual conduct with another; to-wit: E.B., who is not the spouse of the offender, when the offender knows the other person is thirteen years of age or older but less than sixteen years of age, or the offender is reckless in that regard, and the offender is ten or more years older than the other person, in violation of §2907.04(A) of the Ohio Revised Code and against the peace and dignity of the State of Ohio.

COUNT VIII
(Unlawful sexual conduct with a minor, F3)

On or between June 9, 2002 and June 12, 2003, in Madison County, Ohio, or whereby venue is properly placed in Madison County, Ohio, the defendant, Joel T. Cutler, being a person who is eighteen years of age or older, did engage in sexual conduct with another; to-wit: E.B., who is not the spouse of the offender, when the offender knows the other person is thirteen years of age or older but less than sixteen years of age, or the offender is reckless in that regard, and the offender is ten or more years older than the other person, in violation of §2907.04(A) of the Ohio Revised Code and against the peace and dignity of the State of Ohio.

COUNT IX
(Unlawful sexual conduct with a minor, F3)

On or between June 13, 2003 and December 15, 2003, in Madison County, Ohio, or whereby venue is properly placed in Madison County, Ohio,

the defendant, Joel T. Cutler, being a person who is eighteen years of age or older, did engage in sexual conduct with another; to-wit: E.B., who is not the spouse of the offender, when the offender knows the other person is thirteen years of age or older but less than sixteen years of age, or the offender is reckless in that regard, and the offender is ten or more years older than the other person, in violation of §2907.04(A) of the Ohio Revised Code and against the peace and dignity of the State of Ohio.
